## Registration advice

### Right of revocation

You have the right to revoke the contract within 14 days without stating reasons by means of explicit written declaration (e.g. letter, fax or email). The revocation term starts upon receiving this notification in written form but not before the contract is concluded and also does not fulfill our obligations under the article 246 § 2 in relation to § 1 paragraph 1 and 2 EGBGB as well as our obligations according to § 312g paragraph 1 sentence 1 BGB in connection with article 246 § 3 EGBGB.

Timely dispatch of revocation shall suffice to meet the revocation term.

### Consequences of revocation

In the event of an effective revocation the mutually received goods and services as well as any benefits (e.g., interest) must be returned. If you are unable to return the received goods and services as well as benefits (e.g. benefits of use) completely or partly, or only in a deteriorated condition, you will be liable to pay compensation. This may result in your nevertheless having to pay the contractual payment obligations for the period until revocation. Obligations to reimburse payments must be fulfilled within 30 days. For you this time period begins with the dispatch of your revocation declaration and for us it begins with its receipt.

### Special remarks

Your right of revocation expires prematurely if the contract, at your specific request, has been executed in full by both parties before you have exercised your right of revocation.
